Dr. Jeff Pappas, NMSHPO

Dr. Jeff Pappas began his report by congratulating and introducing the incoming State Historian, Robert Martinez.

He then thanked everyone for a successful Historic Preservation Awards Ceremony. All members of the board were invited to suggest any thoughts and ideas for any changes to the event for next year. Dr. Pappas recognized the staff once again for efforts and early preparation for the event, beginning in mid- to late January. Special thanks to Deputy Director Michelle Ensey, Lynette Pollari, Steven Moffson, and Annette Apodaca for coordinating and organizing this year's event.

Dr. Pappas also gave a big thanks to the Sharon Callahan for all her work with the NM Historic Preservation Alliance. She has been working on different digital platforms, websites and has approximately 7 years of long term strategic plans for promoting events.

NMCRIS UPGRADES:

The NMCRIS upgrade 80 page planning document is complete and the RFP for the new system build out is almost complete.

The NMAC Built Environment Workshop will be held on June 8'2019 at UNM Laurel Wallace set the agenda and HPD will be presenting on their HBI forms.

Dr. Pappas thanked the committee, Michelle Ensey, Steven Moffson, Steve Townsend and Scott Geister for helping streamline the forms

HPD-ALLIANCE INTERNSHIP:

Gulia has returned this summer to intern with the NM Historic Preservation Alliance. She has been interning with HPD for a number of years and has expressed interest in archeological research and studies.

HPD ANNOUNCEMENTS:

This year the Archeology Fair will be held in Portales at Black Water Draw. The plan is to take the ARCH Fair all over the state.

SITE PROPOSALS

State Register of Cultural Properties and National Register of Historic Places

The Henge (Chaves County)

The Henge is significant at the local level under National Register Criterion C in the area of art because The Henge, completed in October 1963, is an excellent example of large-scale modern abstract sculpture in New Mexico in the decades after the Second World War. Sculptor Herbert Goldman employed modern materials, mostly steel and concrete, to create megaliths, lintels, and cantilevered forms to evoke English Neolithic imagery. The large, stone-like forms finished with rough concrete and emerging from the earth were unlike any previous artwork in New Mexico. The Henge was built when few other commissions existed for large-scale, secular, abstract sculpture in the state. The Henge is also significance because the creative process shared between Donald B. Anderson and Goldman inspired Anderson to establish the Roswell Artists-in-Residence Program in 1967.

- Member Dr. Bandy moved to approve the nomination for listing in the State Register and forward the nomination to the Keeper of the National Register.
- Member Purvis seconded, and the motion was passed unanimously.
- Committee members discussed the motion with member Richey speaking in favor of. Board voted to approval motion with all members in 4 in favor, none opposed. Mr. Richey abstained from voting.

REPLACEMENT MARKERS/REVISED TEXT

Fort Sumner Cemetery/William "Billy the Kid" Bonney Grave (De Baca County)

SIDE 1

This cemetery is purported to be the military cemetery for Fort Sumner. Fort Sumner was deactivated by the US Army in 1869. A year later the post buildings were sold to Lucien B. Maxwell, one of the largest landowners in New Mexico. Maxwell moved to the area from Colfax County and rebuilt the former officers' quarters into a 20-room Spanish Colonial-style house. Maxwell died in 1875 and is buried in the cemetery.

SIDE 2

William "Billy the Kid" Bonney Grave

1859-1881

Henry McCarty is better known by his alias, William "Billy the Kid" Bonney. His family moved to the New Mexico territory in 1873. Bonney was charged with numerous thefts and involved in nine murders during his brief life. At age 19, he was sentenced to death for the murder of Sheriff William Brady. On April 21, 1881, Bonney escaped from the Lincoln County jail, killing two deputies. He fled to Fort Sumner, the home of many of his friends. Bonney was shot and killed by Sheriff Pat Garrett in Peter Maxwell's house on July 14, 1881. His grave in the Fort Sumner Cemetery was originally marked by a wooden cross.

Española Valley (Rio Arriba County)

SIDE 1

Española Valley lies between the Jemez Mountains to the west and the Sangre de Cristo Mountains to the east. The Rio Grande bisects the valley, creating fertile agricultural lands for dry-land farming. Tewa-speaking Ancestral Puebloans arrived in the valley c.1200 and built cliff dwellings, pueblos, and irrigation systems. Their distinctive pottery and weaving traditions continue today.

SIDE 2

Gaspar Castaño de Sosa and 170 Spanish settlers led an unauthorized expedition to the valley in 1590-1591. Spanish settlers returned in 1598 led by Don Juan de Oñate and established a settlement near the present-day Pueblo of Ohkay Owinge. In the 1880s the valley's population increased with the extension of the Denver and Rio Grande Western Railroad (the Chili Line) along the Rio Grande. The valley has continuously reflected its Pueblo and Spanish heritage.

- Member Purvis seconded, and the motion was passed unanimously.

Pilar (Taos County)

SIDE 1

In 1795, 25 families were granted land along the Rio Grande at Pilar then known as Cieneguilla. The Battle of Cieneguilla was fought nearby in March 1854, wherein a camp of Utes and Jicarilla Apaches inflicted heavy losses on two companies of US Army dragoons. The dragoons lost over a third of their forces and nearly all of their supplies. Their commanding officer was later brought to trial for allegedly instigating the conflict.

SIDE 2

Flechas Rayada, the leader of the Jicarilla camp, extended a peace offer a week after the battle and was refused. The battle perpetuated a campaign against Jicarilla Apache that resulted in their relocation to a reservation near Farmington, NM. Writing of the nomadic Jicarilla, New Mexico's Acting Governor declared that, "the best interests of the Territory ... demand their extinction or their resettlement in pueblos."

Tomas "Black Jack" Ketchum (Union and Colfax Counties)

SIDE 1

In 1795, 25 families were granted land along the Rio Grande at Pilar then known as Cieneguilla. The Battle of Cieneguilla was fought nearby in March 1854, wherein a camp of Utes and Jicarilla Apaches inflicted heavy losses on two companies of US Army dragoons. SIDE 2

Flechas Rayada, the leader of the Jicarilla camp, extended a peace offer a week after the battle and was refused. US Rio Puerco Bridge (Socorro County)

(Same text both sides)

This historic bridge was built in 1930 and features two, steel Parker through-trusses that traverse the Rio Puerco, each with 141-foot spans. Steel-truss bridges were constructed in flood-prone areas and reflect the shift to standardized bridge design in New Mexico during the 1920s. This structure is one of about a half dozen Parker through-truss bridges remaining in the state. It has been preserved by the New Mexico Department of Transportation.

- O Parapet heights are to remain unchanged, with appropriate waterproofing and removal of visible metal components.
- O Roof to be re-framed with the dimensioned wood joists, not composite ones, due to low clearances.
- O No roofing to be visible at top of parapets.
- O Stucco shall be cement-based.
- Member Richey moved to approve.

- o No roofing to be visible at top of parapets.

- Member Purvis seconded and motion passed unanimously.

- I move to table the Part 1 application for **241 Solano Drive**, **NE**, **Albuquerque** pending a written submittal describing roofing and parapet/porch work.

- Member Purvis seconded and motion passed unanimously.

I move to deny the Part 1 application for <u>405 Amherst Drive</u>, <u>NE</u>, <u>Albuquerque</u> as it does not conform to program standards #1, 2, 9, and 10 (cited below) because the front section of the house (including the entire façade and porch, and part of the living room and front bedroom) is to be demolished and a new addition is to be built that will extend the house significantly closer to the street. While the new additions are to be compatible with its extant, historic front portion, the house will have a lost a great deal of its historic and physical integrity. We believe the property will no longer contribute to the historic district (see Stature 7-2-18.2(2013), cited below) because it will have lost its historic integrity through the demolition of the front, character-defining portion of the building. There are further impacts to its site and environment.

- Member Richey motion to deny the Part 1 application.
- Member Purvis seconded and motion passed unanimously.
- Member Purvis then moved that the program standards are to be included in the minutes.
- Member Richey seconded and the motion passed unanimously.

From the program standards

- 1. A property shall be used for its historic purpose or be placed in a new use that requires minimal change to the defining characteristics of the building and its site and environment.
- 2. The historic character of a property shall be retained and preserved. The removal of historic materials or alteration of features and spaces that characterize a property shall be avoided.
- 9. New additions, exterior alterations, or related new construction shall not destroy historic materials that characterize the property. The new work shall be differentiated form the old and shall be compatible with the massing, size, scale, and architectural features to protect the historic integrity of the property and its environment.
- 10. New additions and adjacent or related new construction shall be undertaken in such a manner that if removed in the future, the essential form and integrity of the historic property and its environment would be unimpaired.

Statue NM 7-2-18-2. (2013): B. The taxpayer may claim the credit if...it maintained those qualities of the property that made it eligible for the inclusion in the official register;

Please note that program Rule 4.10.9. and HPD's Guidelines for Eligible Expenses state that all work on the property, including new construction, will be reviewed for conformance with program standards.

Regulation (Rule) 4.10.9 NMAC:

4.10.9.9: Program Requirements:

...All work that will affect the property during the project time frame shall be described, whether or not it is eligible for credit within the program...

4.10.9.12 Non-Creditable Work Items:

B... The committee shall not approve a project or any part of a project which contains any work item which does not conform to Section 11(4.10.9.11 NMAC)

HPD's Guideline for Eligible Expenses for Credit to State Income Tax (July 20, 2016 and also 2003 version): All work on the property undertaken during the 24-month project approval must be described in the application and must meet program standards.
