#### 4. CHAIRMAN'S REPORT

Chairman Ron Toya stated that he had nothing to report from the last meeting but thanked the Committee for their time and support and appreciates what everyone does for the Committee.

5. State Historic Preservation Officer's Report. Dr. Jeff Pappas briefed the Committee on the items below.

NMSHPO's State Plan: Yesterday, NMSHPO submitted to the National Park Service for review their 2022-2032 state plan, which effectively acts as NMSHPO's strategic plan for the next ten years. The process of picking a contractor began in the late summer, early fall of 2020. Sunmount Consulting of Santa Fe, directors Oliver Horn and Robynne Mellor, won the bid and started working with the state plan committee (Michelle Ensey, Karla McWilliams, Gail Craven, Steven Moffson, Rick Reycraft, Cortney Wands, and Melinda Wheeler). The process was long and, I think, thorough, in that the committee reached out to every interested party across the state to solicit their ideas and opinions about the future of historic preservation in New Mexico. Results of the survey, and the plan itself, will be available after the National Park Service approves the plan in early 2022

HPD/Historic Sites Partnership: The Historic Preservation Division will partner with the New Mexico Historic Sites Division to begin a new Cultural Landscape Report for Fort Stanton. As you know, Fort Stanton poses some serious preservation concerns because of its size (88 historic buildings), all of which need significant repair. The CLR will identify the primary interpretive narratives and hopefully inform the restoration efforts over the next ten years. Shortly, HPD will seek a contractor to begin work on the CLR in early spring.

<u>NMCRIS Upgrade</u>: The NMCRIS upgrade (HPD's database) which began two years ago is beginning to show positive results. The contractor, RESPEC, is working almost daily with the ARMS staff manager, Derek Pierce, trouble shooting and adding capacity to the database. The steering committee is now meeting weekly to review the progress and to identify new issues. Key employees working on the update are Derek Pierce and Kendall McGowan. We're hopefully to do broader testing with external users by mid-March.

HR Actions: There are several HR actions in the mix at HPD, and we're hopeful to make some critical hires by early next year, particular at ARMS, who lost three key employees to retirement since June 2020. My appreciation to Michelle Ensey, Gail Craven, and Derek Pierce for moving the HR paperwork through the process. And of course, we'll be looking for a new Business Ops Specialist to replace Annette, who has given excellent service to HPD and the CPRC for the last three plus years. Many thanks to Annette and best of luck in your new endeavor.

<u>CPRC Heritage Preservation Award Ceremony</u>: It's that time of the year to start planning for the CPRC Heritage Preservation Award Ceremony. At this point, because of COVID, we're not certain whether an inperson meeting will be approved. Of course, we're hopeful and I'll keep you updated through the early part of 2022. In the meantime, though, staff will be reaching out to members of the CPRC to brainstorm possible awardees. Also, if you have any ideas about the 2022 poster, email me or Harvey.
