## NEW MEXICO CULTURAL PROPERTIES REVIEW COMMITTEE

# Special Committee Meeting December 16, 2021 1:00PM

Zoom Video Conference, Santa Fe, NM

Chairman Ronald Toya called the meeting to order at 2:00 p.m. Chairman Toya characterized the CPRC as a statutory body established in 1969 under the Cultural Properties Act charged with identifying and advising on the protection of the State's cultural properties. CPRC meetings are run by parliamentary procedure. With the added dimension of meeting virtually and not in person Chairman Toya asked for everyone's patience. In addition, discussion on an agenda item may be suspended and no Committee action will be taken in the event there is an interruption in the audio/video and will only resume if the issue is fixed.

#### 1. APPROVAL OF AGENDA

**Chair:** The motion passes unanimously. Dr. Pappas, do you have any guests you would like to introduce?

Dr. Pappas introduced the staff present and Chairman Toya also acknowledged the presence of Ms. Donna Bevacqua-Young from the Attorney General's Office.

**Chair:** The next item on the agenda is Committee Matters. Who will be presenting this?

#### 2. Committee Matters

a. Memorandum of Understanding between the NM State Historic Preservation Officer, the Middle Rio Grande Conservancy District, and the Cultural Properties Review Committee for the Treatment of Cultural Properties.

Dr. Pappas asked Ms. Ensey to summarize the Memorandum of Understanding. Ms. Ensey summarized the Memorandum, its purpose, and slight changes recommended by Ms. Bevacqua-Young.

Chairman Toya stated he was happy and satisfied with the agreement. He asked for other comments. Member Dr. Bandy had a question regarding termination of the agreement. Dr. Pappas stated that we would try to resolve the issues we had before termination of the agreement. The termination clause is standard in any agreement. If the document did dissolve, we would revert back to standard consultation under state law. Dr. Bandy wondered if it would be easy for MRGCD to bow out of the agreement. Dr. Pappas stated that if MRGCD decided to dissolve the agreement we would enter into consultation with the federal agency (the Bureau of Reclamation) and the MRGCD. Dr. Bandy also asked about the federal agency's analysis of adverse effects. Dr. Pappas stated that very little survey had been conducted and this was one reason why we entered into the MOU. Dr. Bandy stated that if we were satisfied then he was satisfied. Dr. Pappas said he was very happy with the agreement. Member Mr. Uvina, asked about an expiration date on the agreement. Ms. Ensey stated that the agreement term is five years and could be extended if everyone is happy with the agreement. After 10 years, agreements usually need to be updated. Chairman Toya said that most agencies work in good faith but if they wanted to, they could get out of any agreement. Dr. Pappas stated that this is an important resource and could be a national historic landmark. Chairman Toya stated he was comfortable with the agreement. He asked if there was any further discussion and asked for a motion to approve or disapprove.

**Member Dr. Mattson:** I make a motion to approve the Memorandum of Understanding
