4. CHAIRMAN'S REPORT

Mr. Toya expressed that it has been a busy two months since the last CPRC meeting that started with monitoring the Legislative session. The Bills will be discussed in more detail during the next meeting. Mr. Toya had the opportunity to work with Dr. Pappas and Secretary's representative Jane Egan, regarding two new appointments to the CPRC. Garron Yepa from Jemez Pueblo and OAS Architects and Elizabeth Suina from Cochiti Pueblo and Suina Design Architect were appointed. Now with nine members on the Committee, the quorum is now five. The appointments are not final and need to be certified by the Secretary of State. Mr. Toya had several meetings with the Markers Subcommittee and in addition met with Dr. Pappas several times to discuss the CPRC award ceremony.

5. STATE HISTORIC PRESERVATION OFFICER'S REPORT

Dr. Jeff Pappas briefed the Committee on the two new appointees, open positions, and the Legislative session. The session went well and will be discussed in detail during the June meeting which include specifics regarding funding for the NMCRIS upgrade. This year, there was full funding from the Legislature. Also, there was an increase federal funding from the National Park Service grants. Good budget numbers are expected and positions to be filled. There were acknowledgements for the award nominations and staff participation. It was noted that NM Press was not nominated because there was a shortage of books produced but should anticipate the nomination next year.

The St. Theresa Community Center is eligible for listing in the National Register at the local level under National Register Criterion C in the area of architecture because the community center because it is an excellent representative example of a community center, a building type constructed throughout New Mexico, especially during the Great Depression.

Presented by Steven Moffson: The purpose of this additional documentation is to change the name of the Manby House, which was listed in the State Register of Cultural Properties on January 25, 1980, to the Hernández-Manby House. It was believed that Arthur Manby was responsible for constructing the Taos residence in 1907. Recent scholarship, however, indicates that members of the Hernández family previously owned the house and outbuildings, which they sold to Arthur Manby in 1899. Manby purchased an adobe 6-room structure, stables, and an adjacent building. The proposed new name for the property, Hernández-Manby House, more accurately reflects the contributions of the Hernández family and Arthur Manby in shaping the current appearance of the house.

Collette LaBouff acknowledged this historical project and the renaming of the Manby House.
