2. APPROVAL OF AGENDA

Member Dr. Mattson made a **motion** to have two changes made to the agenda. Once items are changed Dr. Mattson **moved** to **approve** the **agenda with changes**. Member Mr. Bandy **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed** by **unanimous approval**.

3. APPROVAL OF THE MINUTES FROM THE PREVIOUS MEETING:

a. March 7, 2025

Member Mr. Martinez made a **motion** to **approve** the minutes from March 7, 2025, as written. Member Dr. Bandy **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed unanimously**.

4. CHAIRMAN'S REPORT

This has been a busy time due to the shortness of the last meeting. Working with HPD on Award Nominations and the Historic Preservation Fund. I attended a couple of sessions of the legislative Budget hearings, and did not present just listened. I have been working with the Markers Subcommittee. All these will be followed further on the agenda.

5. STATE HISTORIC PRESERVATION OFFICER'S REPORT:

SHPO & State Archaeologist Michelle Ensey updated the CPRC with the following information:

Interviews concluded for the State Archaeologist and archaeological review position. There were 31 applications, mostly current federal archaeologists. Narrowed it down to 12 very qualified candidates and then ended up interviewing eight. Two candidates declined the interview. Our next task is to do reference checks for our top candidates. Hopefully we will have a new staff member for June, but it will depend on when the selected person is able to start.

HPD staff will be participating in the Preservation Month Symposium on Saturday, April 26 at the New Mexico History Museum auditorium. Historic Foundation and the City of Santa Fe has put this together, and Karla McWilliams, Steven Moffson, and Matt Saionz will provide an introduction to HPD tax credits, Certified local governments, grant funding and the National and State Register Program.

Planning on the New Mexico State Preservation Conference to be held in Las Vegas October 3-5th is ongoing. HPD has been meeting every two weeks with Cornerstones Community Partnerships and our conference planner to make sure everything is on track. The call for abstracts has closed and we 37. Although the deadline has passed, a few more have been promised so it looks like we will have a great meeting,

We kicked off a new NMCRIS project with our contractor RESPEC. This project will develop a public portal for submission of project reviews, permits, tax credits, nominations, grants, etc. The public portal will eliminate the need to send a lot of emails and documents to staff and our general email and help keep everything more organized in one place. The goal is to have this project completed by the end of December, so I'll have more information later on the functionality of the portal as it begins to be built out.

Mr. Uviña, would it be possible to send reminders for the Preservation Conference. Michelle responded that she will send right after the meeting.

The Chairman introduced and welcomed Autumn Bergh as the CPRC's new Assistant Attorney General.

6. Official Scenic Historic Markers


Mr. Martinez acknowledged that the Official Scenic Historic Markers Subcommittee met earlier this week to discuss the revised text and location for Córdova/José Dolores López, and Las Cruces on the Camino Real. We talked about outreach to the Native American Communities and Matt Saionz will provide more detailed information.

- a. Revised Text/Location
 - i. Córdova/José Dolores López
 - ii. Las Cruces on the Camino Real

Matt Saionz provided the CPRC with a presentation on the Córdova/José Dolores López Marker:

The revision and relocation of the Córdova marker was discussed and approved at our last meeting in February. However, our Dr. Audra Bellmore requested that text for José Dolores López be drafted for the second side. The subcommittee and staff thought that was an appropriate idea. José Dolores López was born in 1868 in Córdova and herded sheep in the early part of his life until buying land in Córdova where he maintained a small herd of goats to sell dairy products and meat. Like his father and grandfather, López practiced carpentry, although he was reported to have not been as skilled as his brothers, and his carpentry, according to one scholar, "was not exceptional." Even as it faded out of fashion, López was also skilled in filigree jewelry, perhaps providing the origins of his later chip-carving. As the story goes, López became deeply depressed when his son Nicudemos was pressed into service in 1917 to fight in the Great War in Europe. Unable to sleep, he turned to whittling at all hours, and before long, he was carving gifts for fellow villagers. From clock shelves to niches, these early works were brightly painted in the traditional Hispano style and began to exhibit his signature chip-carving and incised patterns. In his role as sacristan of the village chapel, López repaired and repainted polychromed images in the chapel, although, according to the same scholar, "his palette was limited and his detail work quite crude." He also produced original polychromed articles, such as a Bible stand and cemetery cross, as well as religious images for the chapel. The honing of his woodworking skills within this religious and communal context set the stage for López's "discovery" in the 1920s by artists and experts from Santa Fe and Taos who had become enamored with the folk traditions of northern New Mexico. The newfound commercial opportunity influenced López to create bultos (sculptures) with his patented carved decorations but that were unpainted to be more palatable to wider markets. López died in 1937, but his distinctive woodcarving is carried on by santeros in Córdova that include his direct descendants

The revised text for Córdova on side 1 was approved at our last meeting, which technically makes the addition of text for López on side 2 a revision. Side 2 reads as follows:



Member Mr. Martinez made a **motion** to **approve** the **revised text** and the **approved final relocation destination by NMDOT for this marker**. Member, Mr. Uviña **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed** by **unanimous approval**.


and shaped a new woodcarving tradition synonymous with Córdova.

Matt Saionz provided the CPRC with a presentation on this Las Cruces on the Camino Real Marker.

Instead of providing a brief history of Las Cruces, it might be more useful to focus on the origins of the placename and its relation to the Camino Real. Las Cruces translates quite literally to "the crosses," and the name refers to a cluster of small crosses that are believed to have been erected either to mark the location of a skirmish between soldiers or travelers and Apaches or, more specifically, the graves of those who died in the fight. While it is not very likely that the crosses marked actual graves, it seems that many historians favor that particular origin story. What's more is the uncertain date of the alleged violence. In the 1690s, a Spanish officer observed crosses near the Organ Mountains, but that could have been anywhere in the area. A handful of travelers in the mid-1840s mentioned passing the crosses near the site of today's city, surmising that there rested the victims of an Apache attack from a few years prior. According to one such account, Governor Manuel Armijo himself was directly involved in the incident with Apache's. Ultimately, we do not have the documentation to determine with any certainty who partook in the violent incident or when it occurred. Indeed, it's quite possible that no skirmish happened at all! The crosses could have simply marked the location of the otherwise natural deaths of unfortunate travelers, not unlike descansos. The other interesting point to mention is that Las Cruces is not known to have been a paraje or camping site on the Camino Real de Tierra Adentro, which technically dates to the colonial period that ended in 1821. In fact, by the time a town was founded in 1848, the Camino Real should more accurately be referred to as the Chihuahua Trail. This is all to say this marker is a lot fun.

The marker is currently located at the Roadrunner Rest Area on I-10 just across the Rio Grande to the west of Las Cruces. Given that the historic Camino Real/Chihuahua Trail likely passed through the heart of downtown Las Cruces, the current location is reasonable. This plan is to simply replace this marker with new text at this location. Interestingly, it seems the plates of this particular marker are mounted on the walls of a rest area building instead of the usual rustic wood posts.

The proposed revised and the original text is as follows:



Member Mr. Martinez made a **motion** to **table until the subcommittee can review** the **revised text suggested changes** and the **approved final location by NMDOT** for this marker. Dr. Jenks **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed** by **unanimous approval**.

Ms. Michelle Ensey updated all CPRC members received the list of nominations which was sent out previous to the CPRC members by Irene Rubio. Are there any questions or concerns about these nominees?

Member Mr. Uviña and Michelle will work together to review with the Historic Belén Bioarchaeology Project on who should be acknowledged for the award.

Member Mr. Martinez has motioned to have all 6 award nominations accepted. Mr. Uviña seconded the motion. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the motion passed by unanimous approval.

b. Cultural Properties Restoration Fund Grants

Michelle Ensey updated the CPRC on the following:

We are still waiting for funding to be released for the first round of grants. The joint powers agreements, which are required to be in place before work can start, were submitted to our administrative services division, and they are waiting to hear from the Department of Finance and Administration as to the adequacy of the Joint Powers agreements before the Cabinet Secretary signs them.

The deadline was March 8th we received 21 applications. Some are nonprofit, which are ineligible. They are reviewing 20 applications and currently half way through review. We will have a list for the subcommittee soon and our goal is to have the subcommittee present the selected grants to the CPRC by the June 6th meeting. The total request is for over 3 million, which is over the 1.2 million grant. Looking forward to next year: HB 2 the general appropriation act of 2025 includes an appropriation from the enchantment legacy fund of \$1,205,700.

Chairman commented that he will be working with HPD to solve the issues and have them approved faster so funding doesn't change and create other problems. People are applying for the amounts they need which will allow us to help with more projects. Working on the administrative part for a fast and clear process. Garron is the chairman of the restoration fund subcommittee, and anyone is welcome to join us. Will be meeting between now and June and we will have a slate of projects that will need to be voted on.

8. SUBCOMMITTEE MATTERS

Tax Credits Projects:

Mr. Francisco Uviña acknowledged this Monday the Architectural Subcommittee reviewed and discussed the applications for the State Income Tax Credit for Preservation of Cultural Property. After reviewing that material and the Tax Credit Memorandum, I would like to make the following motions:

Member Mr. Uviña made a motion to approve the Part 1 Amendment application for 2 Arco Court NW, Albuquerque, with the condition that stucco is to be cementitious and not elastomeric, acrylic, or modified with polymers. Member Dr. Bellmore seconded the motion. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the motion passed by unanimous approval.

- **b.** State Income Tax Credit Projects **Part 1 Application**:
 - i. 429 Aliso Drive NE, Albuquerque

Member Mr. Uviña made a motion to approve the following three Part 1 Applications; 429 Aliso Drive NE, Albuquerque, 603 North Bayard Street, Silver City, and 207 Montclaire Drive NE, Albuquerque as submitted. Member Dr. Bellmore seconded the motion. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the motion passed by unanimous approval.

Member Mr. Uviña made a motion to approve the Part 1 Applications for 405 Montclaire Drive NE, Albuquerque, with the condition that roofing is not to be visible at the parapets from the ground. Member Dr. Bellmore seconded the motion. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the motion passed by unanimous approval.

Member Mr. Uviña made a motion to approve the Part 1 Applications for 718 Old Santa Fe Trail, Santa Fe, with the following conditions and recommendations:

- > Detailed plans and estimates for the front patio repair, adobe repair, and stuccoing the small portion of the north wall are to be provided to staff for review prior to commencing work.
- Any wood and adobes deteriorated beyond repair are to be replaced in kind. Where replacement is necessary, adobes are to be unamended.
- > Stucco, including that used for patching, is to be cementitious and not elastomeric, acrylic, or modified with polymers.
- ➤ It is recommended that a corrugated metal roof rather than the proposed modified bitumen is installed on the front patio. It is recommended that low vegetation is removed adjacent to walls where possible.

Dr. Bellmore **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed** by **unanimous approval**.

Member Mr. Uviña made a motion to approve the Part 1 application for 310 Thirteenth Street NW, Albuquerque, with the following conditions:

- A detailed sketch showing the thickness of the retaining walls, the size of the area to be filled with concrete, and how the house will be supported during concrete pouring is to be provided to staff for review prior to commencing work.
- A site visit by staff and member Uviña and Matt Saionz to evaluate the proposed project is required prior to commencing work. Recommendations, if there are any, will be provided to the applicant in writing.

Member Dr. Bellmore **seconded** the **motion**. The Chair inquired if there is any further discussion, not hearing any, continue with roll call. Ms. Rubio initiated a roll call vote, and the **motion passed** by **unanimous approval**.

Mr. Asher commented that he will be sending maps and two meters across mostly linear due to the locations. An internship and Thesus project will be done for this project. We have not found any burials and organic materials and we are right now at contact as far as 10 thousand years old features we have a lab and fine scale recover botanical remains and will maintain samples to have expert's review. If we do find bones, we do have funding for radiocarbon dating. Dr. Bandy said write that up on a revised proposal and resubmit.
